BY SUBMITTING THE ONLINE APPLICATION YOU ARE AGREEING THAT YOU HAVE READ AND UNDERSTAND THE TERMS AND CONDITIONS OF THIS AGREEMENT AND THAT YOU AGREE TO BE LEGALLY RESPONSIBLE FOR EACH AND EVERY TERM AND CONDITION.

#### 1. Overview

This Agreement contains the complete terms and conditions that apply to you becoming an affiliate in HeimdalSecurity.com's Affiliate Program. The purpose of this Agreement is to allow HTML linking between your website and the www.heimdalsecurity.com website. Please note that throughout this Agreement, "we," "us," and "our" refer to HeimdalSecurity.com, and "you," "your," and "yours" refer to the affiliate.

#### 2. Affiliate Obligations

#### 2.1

To begin the enrollment process, you will complete and submit the online application at the ShareASale.com server. The fact that we autoapprove applications does not imply that we may not reevaluate your application at a later time. We may reject your application at our sole discretion. We may cancel your application if we determine that your site is unsuitable for our Program, including if it:

#### 2.1.1

Promotes sexually explicit materials

#### 2.1.2

Promotes violence

#### 2.1.3

Promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation, or age

#### 2.1.4

Promotes illegal activities

#### 2.1.5

Incorporates any materials which infringe or assist others to infringe on any copyright, trademark, or other intellectual property rights or to violate the law

#### 2.1.6

Includes "Heimdal Security" or variations or misspellings thereof in its domain name

#### 2.1.7

Is otherwise in any way unlawful, harmful, threatening, defamatory, obscene, harassing, or racially, ethnically, or otherwise objectionable to us in our sole discretion.

#### 2.1.8

Contains software downloads that potentially enable diversions of commission from other affiliates in our program.

#### 2.1.9

You may not create or design your website or any other website that you operate, explicitly or implied in a manner that resembles our website, nor design your website in a manner that leads customers to believe you are HeimdalSecurity.com or any other affiliated business.

#### 2.2

As a member of HeimdalSecurity.com's Affiliate Program, you will have access to Affiliate Account Manager. Here you will be able to review our Program's details and previously-published affiliate newsletters, download HTML code (that provides for links to web pages within the www.heimdalsecurity.com website) and banner creatives, browse and get tracking codes for our coupons and deals. In order for us to accurately keep track of all guest visits from your site to ours, you must use the HTML code that we provide for each banner, text link, or other affiliate link we provide you with.

#### 2.3

HeimdalSecurity.com reserves the right, at any time, to review your placement and approve the use of Your Links and require that you change the placement or use to comply with the guidelines provided to you.

#### 2.4

The maintenance and the updating of your site will be your responsibility. We may monitor your site, as we feel necessary to make sure that it is up-to-date and to notify you of any changes that we feel could enhance your performance.

#### 2.5

It is entirely your responsibility to follow all applicable intellectual property and other laws that pertain to your site. You must have express permission to use any person's copyrighted material, whether it be a writing, an image, or any other copyrightable work. We will not be responsible (and you will be solely responsible) if you use another person's copyrighted material or other intellectual property in violation of the law or any third party rights.

We strongly advise affiliates to stay compliant with the Federal Trade Commission (FTC) and European Union guidelines on testimonials and endorsements. #### 2.6.1

You agree not to hack, abuse, adversely interfere with, infect with viruses, worms or other malicious or destructive code, or use or cause to be used in extraordinary and unreasonable or inappropriate ways or amounts, any Offerings, including any servers, bandwidth supply, equipment, software and other technological resources provided by Heimdal Security.

#### 3. www.heimdalsecurity.com Rights and Obligations

#### 3.1

We have the right to monitor your site at any time to determine if you are following the terms and conditions of this Agreement. We may notify you of any changes to your site that we feel should be made or to make sure that your links to our website are appropriate and to notify you further of any changes that we feel should be made. If you do not make the changes to your site that we feel are necessary, we reserve the right to terminate your participation in the HeimdalSecurity.com Affiliate Program.

#### 3.2

www.heimdalsecurity.com reserves the right to terminate this Agreement and your participation in the www.heimdalsecurity.com Affiliate Program immediately and without notice to you should you commit fraud in your use of the HeimdalSecurity.com Affiliate Program or should you abuse this program in any way. If such fraud or abuse is detected, www.heimdalsecurity.com shall not be liable to you for any commissions for such fraudulent sales.

#### 3.3

This Agreement will begin upon our acceptance of your Affiliate application and will continue unless terminated hereunder.

#### 4. Termination

#### 4.1

Either you or we may end this Agreement AT ANY TIME, with or without cause, by giving the other party written notice. Written notice can be in the form of mail, email, or fax. In addition, this Agreement will terminate immediately upon any breach of this Agreement by you.

#### 4.2

Alternatively, Heimdal Security may, at any time, with or without notice, in its sole discretion, suspend, limit, restrict, condition or deny your access to or use of all or any part of the Network or any Heimdal Security material.

#### 4.3

Upon any termination of this Affiliate Agreement and/or your participation on the Network:

#### 4.3.1

You shall immediately cease to use and remove from any and all Site(s), whether or not owned or operated by you, any and all Qualifying Links and all other Content or materials provided to you in connection with your participation in the Network or your use of any other creatives, products or services pertaining to Heimdal Security.

#### 4.3.2

Any and all licenses and rights granted to you under this Agreement shall immediately cease and terminate.

#### 4.3.3

Heimdal Security may terminate or, in its sole discretion, direct or redirect to any destination Site any and all qualifying links continued to be used by you without Heimdal Security or any Network Advertiser incurring any further liability or obligation to you.

#### 4.3.4

Any and all confidential or proprietary information of Heimdal Security (including as applicable any confidential or proprietary information of Network Advertisers as and to the extent originally provided by Heimdal Security) that is in your possession or control must be immediately returned or destroyed, at Heimdal Security's sole discretion. If requested, you will certify in a writing signed by you or an authorized officer as to the return or destruction of all such confidential or proprietary information.

#### 5. Modification

We may modify any of the terms and conditions in this Agreement at any time at our sole discretion. In such an event, you will be notified by email. Modifications may include, but are not limited to, changes in the payment procedures and www.heimdalsecurity.com's Affiliate Program rules. If any modification is unacceptable to you, your only option is to end this Agreement. Your continued participation in HeimdalSecurity.com's Affiliate Program following the posting of the change notice or new Agreement on our site will indicate your agreement to the changes.

#### 6. Payment

#### 6.1

HeimdalSecurity.com uses a third party to handle all of the tracking and payment. The third party is the ShareASale.com affiliate network. Kindly review the network's payment terms and conditions.

#### 6.2

The fact that a compensation amount is reported for any tracked activity does not necessarily mean that a payment is due to you from the relevant Network Advertiser, since payment may be subject to conditions established by that Network Advertiser, including policies regarding order cancellation, returned merchandise, receipt of pending credit card authorizations and/or chargebacks and minimums for earned compensation before payment is made.

#### 6.3

You agree that you are solely responsible for any and all tax obligations, if any, due to all taxing authorities arising from or in connection with any compensation earned by you as a result of your participation in any affiliate activities, the Network or any affiliate campaings.

#### 6.4

Heimdal Security is under no obligation to investigate or resolve any claim or dispute involving you and any Network Advertiser or other third party person. #### 7. Access to Affiliate Account Interface

You will create a password so that you may enter ShareASale's secure affiliate account interface. From their site you will be able to receive your reports that will describe our calculation of the commissions due to you.

#### 8. Promotion Restrictions

#### 8.1

You are free to promote your own websites, but naturally any promotion that mentions HeimdalSecurity.com could be perceived by the public or the press as a joint effort. You should know that certain forms of advertising are always prohibited by HeimdalSecurity.com. For example, advertising commonly referred to as "spamming" is unacceptable to us and could cause damage to our name. You are required to abide by all state and federal consumer protection laws and regulations including the FTC Act and the CAN-SPAM Act in order to be accepted and be part of Heimdal Security's Affiliate Program. Other generally prohibited forms of advertising include the use of unsolicited commercial email (UCE), postings to non-commercial newsgroups, and cross-posting to multiple newsgroups at once. In addition, you may not advertise in any way that effectively conceals or misrepresents your identity, your domain name, or your return email address. #### 8.2

Affiliates that exclusively bid in their Pay-Per-Click campaigns on keywords such as **www.heimdalsecurity.com**, Heimdal Security, www. HeimdalSecurity, www. HeimdalSecurity.com, and/or any misspellings or similar alterations of these—be it separately or in combination with other keywords— and do not direct the traffic from such campaigns to their own website prior to redirecting it to ours, will be considered trademark violators and will be banned from Heimdal Security's Affiliate Program. We will do everything possible to contact the affiliate prior to the ban. However, we reserve the right to expel any trademark violator from our affiliate program without prior notice and on the first occurrence of such PPC bidding behavior.

#### 8.3

Affiliates are not prohibited from keying in prospect's information into the lead form as long as the prospects' information is real and true and these are valid leads (i.e., sincerely interested in Heimdal Security's service).

#### 8.3

Affiliate shall not transmit any so-called "interstitials," "Parasiteware<sup>™</sup>," "Parasitic Marketing," "Shopping Assistance Application," "Toolbar Installations and/or Add-ons," "Shopping Wallets," or "deceptive pop-ups and/or pop-unders" to consumers from the time the consumer clicks a qualifying link until such time as the consumer has fully exited Heimdal Security's site (i.e., no page from our site or any HeimdalSecurity.com's content or branding is visible on the end user's screen). As used herein "Parasiteware<sup>™</sup>" and "Parasitic Marketing" shall mean an application that (a) through accidental or direct

intent causes the overwriting of affiliate and non affiliate commission tracking cookies through any other means than a customer-initiated click on a qualifying link on a web page or email; (b) intercepts searches to redirect traffic through an installed software, thereby causing pop ups, commission tracking cookies to be put in place, or other commission tracking cookies to be overwritten where a user would under normal circumstances have arrived at the same destination through the results given by the search (search engines being, but not limited to, Google, MSN, Yahoo, Overture, AltaVista, Hotbot and similar search or directory engines); (c) set commission tracking cookies through loading of Heimdal Security site in IFrames, hidden links, and automatic pop ups that open HeimdalSecurity.com's site; (d) targets text on websites, other than those websites 100 percent owned by the application owner, for the purpose of contextual marketing; (e) removes, replaces or blocks the visibility of Affiliate banners with any other banners, other than those that are on websites 100 percent owned by the owner of the application.

#### 8.5

Affiliates that are found to be cybersquatting or typosquatting on trademark-related domains will be banned from the program with all their commissions reversed.

#### 8.5

Affiliates should clearly and conspicuously disclose the terms and conditions of any incentives, points, rewards, cash, or prizes promised to consumers in return for their response to any advertisement

#### 9.1

Each party reserves all of its respective rights in the proprietary materials covered by this license. Other than the license granted in this Agreement, each party retains all right, title, and interest to its respective rights and no right, title, or interest is transferred to the other.

You agree that you are an independent contractor and nothing in this Agreement will create any partnership, joint venture, agency, franchise, sales representative, or employment relationship between you and www.heimdalsecurity.com. #### 15.2

The headings and titles contained in this Agreement are included for convenience only and shall not limit or otherwise affect the terms of this Agreement.

#### 15.7

If any provision of this Agreement is held to be invalid or unenforceable, that provision shall be eliminated or limited to the minimum extent necessary such that the intent of the parties is effectuated, and the remainder of this agreement shall have full force and effect.
